SECU FAMILY HOUSE AT UNC HOSPITALS SERVES FAMILIES FROM ACROSS NORTH CAROLINA AND PROVIDED OVER 23,000 NIGHTS OF STAY TO SERIOUSLY ILL UNC HOSPITALS PATIENTS AND THEIR FAMILIES IN 2024-25. THE AVERAGE LENGTH OF STAY FOR FAMILY HOUSE GUESTS IS 5 NIGHTS. THE LARGEST PATIENT POPULATIONS AT FAMILY HOUSE INCLUDE OVER 55% CANCER RELATED, INCLUDING SURGERY, AND BONE MARROW TRANSPLANT; WITH OTHER LARGE POPULATIONS TO INCLUDE ORGAN TRANSPLANT, NON-CANCER RELATED SURGERY, TRAUMA, NEUROLOGY, AND CARDIOLOGY.
