Children need healthy meals to learn. Arts Academy at Estrella Mountain (AAEM) proudly offers healthy meals to students during school days. Our school is participating in a federal program available to select schools as part of the National School Lunch Program and School Breakfast Program called **Community Eligibility Provision**. This means that all students attending AAEM are eligible to receive **breakfast and lunch at no cost** throughout the **2026-2027 school year** regardless of family or household income. No further action is required of you. Your child(ren) will be able to receive free meals without having to pay a fee or submit an application.
