

YJR Waiver 2020

By registering for this event you acknowledge to hold harmless any and all persons and entities associated with this event including the organizers, Fleet Feet, YellowJacket Racing, Monroe County Parks, Monroe County, New York State, all volunteers, first responders, K&K and their affiliates of any and all consequences during the running of the event. You understand that running/walking carries with it inherent risks. Specific to this event you have varied and unpredictable surface, sometimes slick conditions and without safety supervision, and the potential for varied temperatures which could lead to heat exhaustion, stroke or hypothermia among some occurrences.

Adding to the risk pool in 2020 is the possibility of contracting COVID 19 during the event. While we are making modifications to the course and event format to reduce risk of transmission between and to both volunteers and entrants, the risk remains of spreading and/or contracting the virus at various points of the event, whether from surface contact, or exposure between individuals. By signing this waiver you acknowledge reading and understanding the risk reducing measures and protocols we are putting into place, and agree to abide by them in the context of the event. You further agree to hold harmless all parties, individuals, and entities putting on, volunteering, supporting, or participating in the event, whether deemed to be at fault, or not, from being held liable for any health implications, immediate or long term, associated with but not limited to COVID 19.

I am aware that the COVID-19 pandemic creates additional risks of participation in the Event. I acknowledge that by participating in the Event, I risk exposure to the novel coronavirus and/or development of COVID-19. I acknowledge that I am voluntarily choosing to participate in the Event and have considered those risks. I expressly and specifically assume such risks associated with the novel coronavirus and/or COVID-19, including any and all risk of injury, harm, or loss that may incur as result of participating in the Event.

By signing this document, I certify that 1) I have not traveled out of the country, nor been to the following states listed on the NYS quarantine list at time of event nor been in close contact with anyone who has traveled out of the country within the past 14 days; I attest I am a New York State Resident. I also attest that should the state quarantine list change on race day that I have not traveled to those locales (2) I have not had close contact or cared for someone diagnosed with COVID-19 within the last 14 days; (3) I have not experienced or been near anyone who experienced. any cold or flu-like symptoms (cough, shortness of breath/trouble breathing, fever greater than 100.4, chills, sore throat, new loss of taste or smell, headaches, muscle aches, rashes) in the last 14 days. I attest that I have not tested positive for COVID-19 in the last 14 days. I understand and agree that my participation in the Event is a re-certification of the above statements and agree to respond to questions the day of the Event if asked to do so to confirm the accuracy of my health condition. I agree that if any of these statements are not true and accurate as of date of the Event, I cannot and will not participate in or be present at the Event. I agree that I will follow the rules that the Event Director mandates for participation in the Event, including, but not limited to, rules related to social distancing and provided amenities.

I agree and acknowledge that no food, water, or other beverage or snack will be provided at the Event or at least very limited. I agree and understand that I am solely responsible for bringing the supplies I may need to participate in the Event. In addition, I will have my temperature taken at the start line. Anyone over 100 degrees will not be allowed to race.
