TOWN OF WENDELL BOARD OF COMMISSIONER MEETING MINUTES APRIL 24, 2017

The Wendell Town Board of Commissioners held their regularly scheduled meeting on Monday, April 24, 2017, in the Town Board Room, Wendell Town Hall, 15 East Fourth Street.

Mayor Gray called the meeting to order at 7:00 p.m. and welcomed attendees.

Item Summary:

Ian Joseph Reddy is originally from Sacramento, CA and moved with his family to North Carolina where he spent much of his youth in and around Wake County. Ian is a graduate of Clayton High School. Upon graduating high school, Ian attended Johnston Community College's Basic Law Enforcement Training program which he completed in May 2013.

After completing the Basic Law Enforcement Training program, Ian immediately began his law enforcement career. Ian has over 3 years of law enforcement experience. Ian's most recent position was with the Topsail Police Department. Having grown up in Wake and Johnston Counties and having family near Wendell, Ian sought to move back to this area to continue his law enforcement career.

Ian is currently a resident of Raleigh. He was sworn in as a police officer with the Town of Wendell on April 12, 2017 and began his field training program the same day.

8. PRESENTATION BY JOE BEAMAN OF LOCAL EMERGENCY PLANNING COMMITTEE (LEPC) TO DISCUSS LEPC INITIATIVES REGARDING SMART GROWTH AS IT RELATES TO CHEMICAL FACILITIES. SPEAKER: Police Chief Carter. ACTION: Presentation.

<u>Item Summary</u>:

The Wake County Local Emergency Planning Committee (LEPC) is a federally mandated committee with membership from business and industry; emergency response groups such as fire, medical and law enforcement; community groups; media; hospitals; environmental interest; universities; and the general public. Wendell Police Chief Bill Carter serves as the Wake County Law Enforcement representative on the LEPC

The mission of the LEPC is to effectively plan for emergencies involving hazardous materials. Its primary responsibility is to receive information about hazardous substances from industry and to use this information to develop comprehensive site emergency plans to handle emergencies. It is also responsible for establishing procedures and programs which make it easy for citizens to understand and have access to the information that the industry submits.

Mr. Joe Beaman is the past Chairman of the LEPC and currently serves as the Chairman of the Land Use Sub-Committee. Mr. Beaman is the President and Chief Geologist of Highland Environmental Solutions located in Raleigh. Mr. Beaman has over 21 years of experience in field investigations, as well as supervisory and project management roles for environmental and emergency response projects.

Mr. Beaman will be speaking to the Town Board about the LEPC's efforts to initiate smart growth around existing chemical facilities in Wake County in order to protect sensitive populations and first responders in the event of a chemical emergency. The goal of the presentation is to raise awareness of the issue and provide an overall view of the LEPC initiatives to address it.

Police Chief Bill Carter introduced Joe Beaman who will discuss Local Emergency Planning Committee (LEPC) initiative regarding smart growth as it relates to chemical facilities; staff report included above in italics.

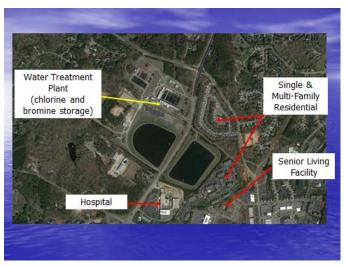

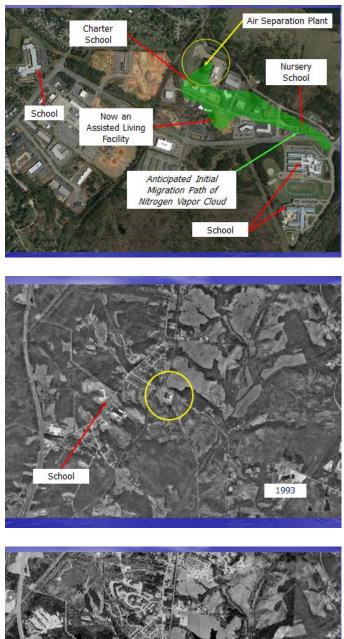

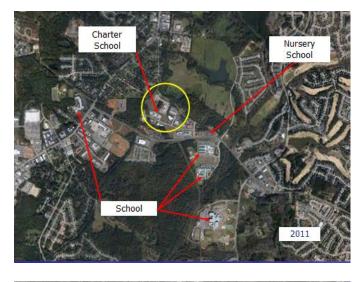


















So, we recognized a concern...what have we done?

Commissioner Boyette heard the LEPC is a federally mandated committee and the upcoming federal budget has steep cuts and questioned if that will curtail LEPC activities. Mr. Beamon stated the LEPC does not receive federal funding.

9. DISCUSSION OF BIDS RECEIVED FOR THE PARTF PROJECT AND POSSIBLE AWARD TO LOWEST RESPONSIBLE BIDDER. SPEAKER: Town Manager Piner ACTION: Board may take action.

[Staff Report]

Specific Action Requested:

On April 17, 2017, the Town received five sealed bids for the Wendell Town Park Improvements. Upon review of the bid packets, the lowest responsible bidder has been certified by Susan Hatchell and Associates as S.T. Wooten at \$533,921.31.

In order to be included in the upcoming Local Government Commission (LGC) agenda for financing of this project, staff respectfully requests the Board take action to award the PARTF project to S.T. Wooten.

<u>History</u>:

During the meeting held on October 27, 2014 the Town Board voted for Parks and Recreation Director Jeff Polaski to apply for a Parks and Recreation Trust Fund Grant (PARTF). After speaking with Recreation Resource Services staff and reviewing the Comprehensive Master Plan developed by East Carolina University, the proposed projects were narrowed to include a multipurpose field (soccer, field hockey, lacrosse, ultimate frisbee, etc...), playground to include a tot lot, a paved walking trail around the ball fields, paved parking lot, and a games court area (bocce, shuffleboard, and horseshoe pits).

The grant was prepared and submitted and the Town of Wendell was awarded a \$250,000

PARTF grant on October 30, of 2015. The Town entered into a contract with Susan Hatchell engineers. Since that time engineering, plans, permits and bids have been prepared. To date, the playground has been installed and parking area has been paved. Items remaining include the multi-purpose field, concrete walking trail around the fields, and games court. Construction is anticipated to begin upon approval from the LGC and bids for financing are received from area banks.

Town Manager Piner provided an overview of the bids received for the PARTF project; staff report included above in italics. The lowest responsible bidder certified by Susan Hatchell engineers was S. T. Wooten for \$533,921.31. The Town will receive \$250,000 as reimbursement for the PARTF grant. Staff is seeking Town Board action in order to proceed with the LGC application.

ACTION:

Mover: Mayor Pro Tem Lutz moved to awarding the bid to the PARTF project to S.T. Wooten. Vote: Unanimous.

10. Discussion of applications received for citizen advisory boards. SPEAKER: Special Assistant to the Manager Scoggins ACTION: Discussion; Board may take action at its May 8, 2017 meeting.

[Staff Report]

Specific Action Requested:

Recruitment for the citizen advisory boards launched on Tuesday, February 28, 2017, and wrapped-up on Tuesday, April 4, 2017.

Applications were reviewed for those boards with residency requirements. Those meeting the requirements are included in the packet for consideration. Applicants living outside of the residency requirements were notified of their ineligibility to serve at the municipal level and provided information about Wake County citizen advisory boards.

Letters were mailed to the applicants on April 7th with an invitation to hear the business of the April 24, 2017 regular meeting <u>and</u> invited to stay afterwards to meet the mayor and commissioners.

Action by the Board is requested at the May 8, 2017, Town Board meeting.

Special Assistant to the Manager Scoggins provided an overview of the applications received for the Town's citizen advisory boards; staff report included above in italics. Board applicants were asked to stand so the Town Board could see who was in attendance and asked applicants to stay after the meeting to meet the elected officials.

11. DISCUSSION OF THE WENDELL WOMAN'S CLUB LEASE, CONTINUED FROM THE APRIL 10, 2017, BOARD MEETING. SPEAKER: Town Manager Piner ACTION: Discussion. Board may take action.

[Staff Report] Specific Action Requested:

The Wendell Woman's Club and Town of Wendell entered into a ten-year lease agreement effective May 12, 2009.

Ms. Sally Mathues, President of the Wendell Woman's Club, contacted the Town sharing the Club's intent to rent the Wendell Woman's Club to a third party on a long term basis. The Club has indicated that rental of the facility would provide:

- Steady income to continue civic projects, scholarships, prison visits, battered and abused women and project operation smile.
- Daily use would keep the building from neglect, deterioration and vandalism.
- There would be no changes to the use of the grounds and parking lot by the town and other civic events to include light show and international food festival.
- The club would provide an Art and Craft center for children and adults.

As the current lease agreement does not allow for the transfer of the lease, this is being brought before the Board for discussion.

Town Manager Piner provided an overview of the Wendell Woman's club lease; staff report included above in italics. The current lease was executed in May 2009 for a ten-year period. If the Board chooses to allow a third party within the Woman's Club facility, the sub-lease would not exceed the duration of the current lease (two years).

Mayor Pro Tem Lutz questioned if the sub-lease was reviewed by the Town Attorney. Town Manager Piner stated he did review and he noted the sub-lease cannot exceed the duration of the primary lease.

ACTION:

Mover: Mayor Pro Tem Lutz moved to approve the sub-lease for two-years and to include the comments: **1** Paragraph 4 needs to include language that the Tenant's parking is subject to priority use by the Town if needed for Town events; **2** Paragraph 6 needs to contain an end date that coincides with the date of termination of the lease between the Town and the Woman's Club. The sub-lease cannot extend longer than the primary lease; **3** Paragraph 14 needs to provide that renewal will be subject to renewal of the primary lease; **4** Paragraph 19 states that the tenant is not responsible for insurance. This needs to be changed to require coverage and to require that the policy name the Town as an additional insured; **5** I would recommend a new paragraph at the end below the existing signature blocks that would read as follows and would then be signed by the Town, the Woman's Club and the new sub-tenant: "The parties acknowledge that this sublease agreement is subordinate to and subject to all terms and conditions set forth in that Lease Agreement between the Town of Wendell, as Owner/Landlord, and the Wendell Woman's Club, as tenant, dated May 12, 2009 (the "Lease"). To the extent of any conflict between the Lease and this sublease, the terms of the Lease shall control." Vote: Unanimous.

12. DISCUSSION OF RESOLUTION TO HONOR JAKE MAY; RESOLUTION WILL BE AVAILABLE AT THE BOARD MEETING. SPEAKER: Mayor Gray ACTION: Board may take action.

Town Manager Piner stated this is a formal process to name the Large Field to Jake May Field.

Mayor Gray stated the Town had a wonderful event this past Saturday. Jake May's family was invited to Wendell. Many people were involved and it was a successful surprise. The Town celebrated Jake May because he is Wendellian with a hope to have Jake May inducted into the North Carolina Sports Hall of Fame.

ACTION:

Mover: Mayor Pro Tem Lutz moved to adopt the resolution renaming the Large Field to Jake May Field [Filed as Resolution Number R-08-2017]. Vote: Unanimous.

Commissioner Carroll stated the Technical Review Committee did not meet in April.

Mayor Gray stated CAMPO the meeting was a review of CAMPO 101.

Mayor Gray stated the Conference Table will meet in May.

Commissioner Myrick stated he attended the quarterly East Wake Senior Center meeting and discussed ADA access for the doors and new signage. During the budget discussions, the Town Board discussed funding half for the ADA door access and the Senior Center raising the other half.

14. COMMISSIONERS' REPORTS.

Commissioner Joyner stated he attended the Jake May Opening Day. He stated a good crowd was coming in for the day. He stated Emerson Kate Joyner arrived April 15 and he and wife are excited to have her in Wendell.

Commissioner Boyette congratulated Commissioner Joyner on his newest family member!

Commissioner Myrick congratulated Commissioner Joyner! He expressed a special thanks to the Wendell Historical Society and Town staff for making Jake May Day possible.

Mayor Pro Tem Lutz concurred with the comments for Jake May Opening Day. He thanked all who applied for a citizen advisory board.

Commissioner Carroll stated his thanks to citizens who applied for Town boards.

15. MAYOR'S REPORT.

Mayor Gray stated she attended the Jake May Opening Day. She stated it was a great event and she thanked the Jake May family for attending. She thanked the Wendell Historical Society for their work on Jake May Opening Day. She thanked the Parks & Recreation staff for making the day special.

Mayor Gray stated she recently attended a retirement reception for Coach Richard Sykes. He is a Wendell native who has lived in Wendell his entire life. He is celebrating 46 years as the head golf coach at NC State. He is retiring at the end of this season.

Mayor Gray stated the Arbor Day celebrations wrapped up last week. Five trees were planted in four different locations around Town. When Phillip Smith and the Tree Board do the tree planting ceremony, it includes a presentation and involves the children at the schools.

Mayor Gray did a radio interview a week ago on "What's Right in Wendell?" The interview was done by 96.1 and the interviewers plan to visit Wendell.
