

What is a bond?

- A bond is just one way the Town can borrow money to pay for a capital project.
- Bonds are different from other ways to borrow money because bonds almost always require approval by the voters.

Why choose a bond?

- Why would you choose a bond instead of one of the ways that doesn't require voter approval?
 - 20-year financing is available on even relatively small amounts financed.
 - No need to worry about collateral value or project revenues
 - Voter approval provides buy-in

What's the process like?

- Starts with an LGC discussion
- Informal process
- Formal process
- During the referendum run-up
- For a referendum in May, need to have the formal process wrapped up by the end of February.

What do the voters approve?

- They approve \$X amount of bonds (as determined by the Board) for a general stated purpose, such as "bonds for streets and sidewalks"
- Separate ballot questions for each separate purpose

What happens after the referendum?

IF the voters APPROVE:

- Coordinate financing schedule with the construction schedule
- Start the financing schedule 90 to 120 days before you want the money in hand
- Seven years to issue the bonds (can be extended to ten)

What happens after the referendum?

IF the voters say NO:

- Wait at least a year before proposing the same program
- OR substantially revise the bond program



2017 Potential ETJ Extension

- ETJ extensions must be approved by both the County and the Town, with public hearings held by each authority. Approval would add additional area under the town's zoning and development jurisdiction.
- Last ETJ Extension occurred in 2012 and added 2179 acres to the Town's ETJ.
- Area under consideration for ETJ extension now would add an additional 691 acres (see map). The intent of the request is to support areas for commercial and industrial development.
- The ETJ extension process would take approximately 8-12 months.
- Wake County Econ. Development has stated they would support the Town's request to the County, as it would support industrial development in the area.



Planning Director David Bergmark provided an overview of extra-territorial jurisdiction (ETJ) expansion for the Wendell Boulevard and Rolesville Road; report included above in italics.

5. 2017 MID-YEAR RETREAT OVERVIEW; STAFF AVAILABLE FOR QUESTIONS.

SPEAKER: Town Manager Teresa Piner

ACTION: Discussion.

Town Manager Teresa Piner provided an overview of the 2017 Mid-Year Retreat report; report incorporated into the minutes at Attachment B.

Mayor Pro Tem Lutz questioned how many streets are unpaved. Town Manager Piner stated five or six.

Town Manager Piner stated staff met with the City of Raleigh to discuss House Bill 436 [an act to provide for uniform authority to implement system development fees for public water and sewer systems in North Carolina and to clarify the applicable statute of limitations] and its possible impact on the Town of Wendell. A webinar is scheduled for Thursday, August 17, 2017 at 10:30 a.m. The Town Board was invited to attend.

Commissioner Joyner questioned the weather camera. Town Manager Piner stated the Town is assessing sites and the weather camera is in the testing phase.

IT Administrator Hughes stated for the weather camera she is working with WRAL. When asked about other stations, IT Administrator Hughes stated she would check with other stations.

Commissioner Joyner questioned the need for a policy for the weather camera footage.

6. BOARD DEBRIEF AND WRAP-UP

SPEAKER: Mayor Virginia Gray and Town Manager Piner

ACTION: Discussion.

Based upon question by the Town Board, Police Chief Carter stated he is keeping an eye on the emissions from the three Ford Explorers in the fleet. Carbon monoxide devices are in each of the vehicles.

Based upon question by the Town Board, Parks and Recreation Director Polaski stated the PARTF project is continuing. The multi-purpose field is level and irrigation will be laid next week to see if it will work. Drainage work on the Doug Proctor field continues. The electric line that was cut was from a former project and did not impact the fields. The walking trail will commence after the Doug Proctor field is completed.

Based upon question by the Town Board, Parks and Recreation Director Polaski stated the fencing and old courts from the tennis courts are removed. The colors on the tennis practice board will be updated to the current Town colors.

The Town Board requested a ribbon cutting when the new tennis courts are completed.
