TOWN OF WENDELL BOARD OF COMMISSIONER MEETING MINUTES February 26, 2018

The Wendell Town Board of Commissioners held its regularly scheduled meeting on Monday, February 26, 2018, in the Town Board Room, Wendell Town Hall, 15 East Fourth Street.

PRESENT: Mayor Virginia Gray; Mayor Pro Tem Jon Lutz; Commissioners: John Boyette, David Myrick, Ben Carroll, and Jason Joyner.

Mayor Gray called the meeting to order at 7:00 p.m. and welcomed attendees.

PROCLAMATION CELEBRATING THE CENTENNIAL OF WENDELL FIRST BAPTIST CHURCH

WHEREAS, the church membership increased and the church school moved to a two-story building known as the "Lodge House."

WHEREAS, the brethren of church purchased the property from C. J. Todd and Amanda Todd for \$35;





7. REQUEST BY WENDELL COUNCIL OF CHURCHES FOR WAIVER OF COMMUNITY CENTER RENTAL FEE.

SPEAKER: Parks & Recreation Director Jeff Polaski

ACTION: Board may take action.

Item Summary

The Wendell Council of Churches is a non-profit organization comprised of eight churches within the Wendell community.

The Wendell Council of Churches submitted a waiver of community center rental fee application for its upcoming National Day of Prayer on May 3, 2018. The request is to set-up for the event at 6:30 p.m. with the event beginning at 7:15 p.m. and concluding at 8:30 p.m. The Wendell Council of Churches anticipates 200 persons attending.

The Wendell Parks & Recreation Commission received the request at its February 5, 2018, meeting. Based upon the information within the application, the Wendell Parks & Recreation Commission unanimously approved the request with the condition that the cost for the police office and cleaning fee would not be waived.

Parks and Recreation Director Jeff Polaski provided an overview of the request by the Wendell Council of Churches for waiver of the Community Center rental fee; staff report above in italics.

8. DISCUSSION OF REQUEST FOR SIDEWALK FEE-IN-LIEU FOR PHASE 3A OF OLDE WENDELL.

SPEAKER: Planning Director David Bergmark

ACTION: Board may take action.

Item Summary

In May of 2015, plans were approved for 10 single family residential lots (5 on each side of Garden Club Way) to be developed along the entrance of the Olde Wendell Subdivision, known as Olde Wendell Phase 3. Based upon the existing zoning designation for this area (R4), sidewalk was required on both sides of Garden Club Way. The approved preliminary plan and construction drawings reflected this requirement. Wendell's policy is to allow sidewalks to be installed lot by lot as homes are constructed in order to minimize damage to the sidewalk during the construction process. The sidewalk must be in place prior to the certificate of occupancy being issued for each home.

In late January, as the first home was nearing completion, town staff reminded the builder that the sidewalk would need to be installed prior to issuance of a Certificate of Occupancy (CO).

Due to expressed concerns regarding sidewalk installation, town staff conducted a site visit to evaluate potential conflicts. Based upon that site visit, staff found that installing the sidewalk as shown on the plan would be cost prohibitive due to the grade at the site, as well as infrastructure conflicts such as electrical boxes (Attachments A, B, and C).

On February 6th, staff met with the developer of Olde Wendell, Phase III to address the sidewalk issue. The developer asked staff to move forward with processing a sidewalk fee-in-lieu request for the Board's consideration for the south side of Garden Club Way (Attachment D). The UDO permits sidewalk fee-in-lieu requests, with Town Board approval.

For reference, On March 9, 2015, the Board of Commissioners approved a sidewalk fee-in-lieu request in the amount of \$9,912.87 on the boundary of the Olde Wendell, Phase III project, for sidewalk installation along Wendell Boulevard.

The submitted fee-in-lieu request would not change the requirement for sidewalk to be installed on the opposite side of Garden Club Way. The developer has committed to staff to have their contractor grade for the installation of sidewalk on the north side of Garden Club Way. Furthermore, in order to avoid potential conflicts with existing infrastructure on the north side of the road, the developer proposed to locate the sidewalk further from the existing road-side right of way and drainage ditch within a proposed sidewalk easement.

The adopted fee schedule lists a sidewalk fee-in-lieu in the amount of \$25 per linear foot. The linear footage of the sidewalk required on the south side of Garden Club Way is 514 feet. This results in a sidewalk fee-in-lieu amount of \$12,850 that would be due prior to the release of the first certificate of occupancy.

Staff Recommendation:

Staff believes that the \$12,850 for the sidewalk fee-in-lieu is a reasonable request based on current site conditions. If the request is approved, there would still be sidewalk present on one side of the road.

Staff recommends approval of the fee-in-lieu request.

Planning Director David Bergmark provided an overview of the request for sidewalk fee-in-lieu for Phase 3A of Olde Wendell; staff report above in italics.

Mayor Gray questioned if there will be a complication across the road. Planning Director Bergmark stated it can be pulled further behind the ditch, within an easement. He added the Town Board may deny the request if the developer submitted a fee in lieu request for the opposite side of the road, and require the installation of the sidewalk.

Mayor Gray questioned if there is a section on this side that if granted that will just stop. Planning Director Bergmark stated the cross over at Wendell Boulevard is at Garden Club Way.

Mayor Pro Tem Lutz questioned is the \$12,000 for those lots or for the entire side of the street. Planning Director Bergmark stated it is for the entire side of the street.

Mayor Pro Tem Lutz questioned if this was an oversight by the developer. Planning Director Bergmark stated the construction drawings showed what the grade should be. There are a couple of light poles that would have needed to be moved and a drainage area to be accommodated. The developer's engineer was aware of most of this. The builder was not aware of the constraints for these sites.

Mayor Pro Tem Lutz stated he attended Princesses in the Park on Saturday with his daughter. He and his daughter had a good time and it was well done by the staff. He also attended the Party with a Purpose and it do was well done and organized!

11. MAYOR'S REPORT.

Mayor Gray stated the citizen board applications are being accepted February 27, 2018 through April 3, 2018. Citizen Boards carried out the Party with a Purpose and each board helps within the Town.

Mayor Gray stated since the last meeting, the Town has hosted Princesses in the Park, Party with a Purpose and Bond with the Blue. There is a lot happening and a lot more to come. She suggested keeping an eye on social media and the website.

Mayor Gray also thanked the Wendell Rotary Club and Dr. Lutz for organizing the State of the Town Address. She stated 2017 was a great year last year!
