Budget ordinance amendment for FY 2019-2020.

### **Specific Action Requested:**

• Staff requests that the Board of Commissioners approve the budget ordinance amendment for FY 2019-2020.

#### **Item Summary:**

For audit purposes, the town is required to adopt the proposed budget ordinance amendment for FY 2019-2020 to "true-up" the various line items within each department (see attachment). The amendment is used to eliminate the negative line items within each department. This is the normal end of the year process to help prepare for the annual audit. However, a summary of revenues, expenditures and fund balance can be reviewed below.

### **Revenues:**

For the fiscal year, there were increases in revenues from various types as follows:

- *Growth* Property Taxes, DMV Revenue, Utility Franchise, Local Option Sales Tax, Development/Planning Fees, and Solid Waste Fees
- *One-time items* these items occurred only once during the fiscal year. The items were Grant Wake ABC
- *New Revenue* line items that were established for the fist time this fiscal year. The new line item was Engineer Review Fees
- *Interest Rate* During the fiscal year the interest rate started at 2.7%; however, the rate has dropped to 1% to end the fiscal year. Earnings continued to exceed budget amount

# Expenditure:

For the fiscal year, there were increases and decreases from various departments as follows:

- *Governing Body* Miscellaneous Expense allows board members to attend social gathers and to acknowledge staff announcements such as new births or deaths.
- Administration Salaries mid-year hiring of new Human Resource Administrator, Professional Services – Legal to cover anticipated expenses for legal fees, Advertising – the visit Raleigh insert
- *Information Technology* License and User Fees purchase new software NeoGov, Contract Services – implement new contract for support services with Carolinas IT, Non-Capital Expense Items – new equipment for virtual board meetings, Capital Outlay-Equipment – new server to replacement dated server
- *Finance* Salaries promotion of Senior Accountant, Bank Service Charges fees charged from bank

- *Economic Development* Façade grant related to the NC Department of Commerce grant and expenses from Appearance Committee
- *Planning* Salaries hiring of Assistant Planning Director, Professional Services engineering and legal costs related to development, Contract Services to cover loss of staff and contract with a third-party for expertise and skilled knowledge.
- *Public Buildings and Grounds* Maintenance to address electrical issues, mulch, and roof for Senior Center, Facility & Equipment Rental new rental for downtown parking space, Contract Service Landscaping to cover new contract.
- *Police* Maintenance Vehicles to replace tires and vehicle repairs, Uniforms to cover new staff and for replacement of existing officers, Capital Outlay Equipment for the purchase of new cars.
- Public Works Maintenance and Utility costs associated with the accounting for new development, Maintenance and Repair equipment and vehicle costs for maintaining the fleet, Equipment Rental for rugs at building and aircards, Fuel Expense new diesel tank, Contract Service to replace and upgrade various areas in town based on growth demands, Capital Outlay Equipment to purchase new dump truck, Contract Services Leaf & Limb to cover costs associated from moving from the old service to new carts.
- *Parks and Recreation* increase in various line items for growth in programs (Part-time, Maintenance, Equipment Rental, and Fuel). Also, the Master Plan was completed.
- *Non-Departmental* Safety Program Expense mandatory drug testing for CDL and pyche test for officers, Emergency Preparedness expenses related to COVID19.
- *Special Appropriations* Wendell Historical Society additional amount to fund Fourth of July event

# Fund Balance:

With the increase in revenues as noted above, the amount of fund balance appropriated of \$696,500 and the additional \$800,000 appropriated for capital projects may not be spent prior to year-end as anticipated. The actual amount of fund balance will be determined during the audit process.



The Citizen Advisory Board recruitment process was adjusted to provide safe social distancing at Town Hall during COVID-19. Staff requested on Tuesday, May 12, 2020 that the Board of Commissioners review the applications sent via email for the Planning Board and Economic Development Committee and follow up with applicants on any questions concerning their application.

The Tree Board has five (5) vacancies with terms lasting for three years. The Parks and Recreation Commission has two (2) vacancies with terms lasting for 3 years for adults, 1 year for youth.

Due to the results of the previous Citizen Advisory Board recruitment, the Town now has zero applications to be considered for the Parks and Recreation Commission and one application to consider for the Tree Board.

Closed Session [NC GS 143-318.11].

# **Specific Action Requested:**

Will be called if necessary for one or more of the following within NC GS 143-318.11(a):

(1) To prevent the disclosure of information that is privileged or confidential pursuant to the law of this State or of the United States, or not considered a public record within the meaning of Chapter 132 of the General Statutes.

(2) To prevent the premature disclosure of an honorary degree, scholarship, prize, or similar award.

(3) To consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege between the attorney and the public body, which privilege is hereby acknowledged. General policy matters may not be discussed in a closed session and nothing herein shall be construed to permit a public body to close a meeting that otherwise would be open merely because an attorney employed or retained by the public body is a participant. The public body may consider and give instructions to an attorney concerning the handling or settlement of a claim, judicial action, mediation, arbitration, or administrative procedure. If the public body has approved or considered a settlement, other than a malpractice settlement by or on behalf of a hospital, in closed session, the terms of that settlement shall be reported to the public body and entered into its minutes as soon as possible within a reasonable time after the settlement is concluded.

(4) To discuss matters relating to the location or expansion of industries or other businesses in the area served by the public body, including agreement on a tentative list of economic development incentives that may be offered by the public body in negotiations, or to discuss matters relating to military installation closure or realignment. Any action approving the signing of an economic development contract or commitment, or the action authorizing the payment of economic development expenditures, shall be taken in an open session.

(5) To establish, or to instruct the public body's staff or negotiating agents concerning the position to be taken by or on behalf of the public body in negotiating (i) the price and other material terms of a contract or proposed contract for the acquisition of real property by purchase, option, exchange, or lease; or (ii) the amount of compensation and other material terms of an employment contract or proposed employment contract.

(6) To consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee; or to hear or investigate a complaint, charge, or grievance by or against an individual public officer or employee. General personnel policy issues

may not be considered in a closed session. A public body may not consider the qualifications, competence, performance, character, fitness, appointment, or removal of a member of the public body or another body and may not consider or fill a vacancy among its own membership except in an open meeting. Final action making an appointment or discharge or removal by a public body having final authority for the appointment or discharge or removal shall be taken in an open meeting.

(7) To plan, conduct, or hear reports concerning investigations of alleged criminal misconduct.

(8) To formulate plans by a local board of education relating to emergency response to incidents of school violence or to formulate and adopt the school safety components of school improvement plans by a local board of education or a school improvement team.

(9) To discuss and take action regarding plans to protect public safety as it relates to existing or potential terrorist activity and to receive briefings by staff members, legal counsel, or law enforcement or emergency service officials concerning actions taken or to be taken to respond to such activity.
