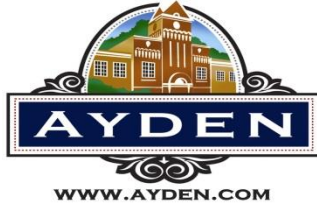

1. Service Characteristics

- A. The customer shall not use the electric power and energy furnished hereunder as an auxiliary or supplement to any other source of power and shall not sell electric power and energy purchased hereunder.

2. Payment

- A. The Customer shall pay the Town of Ayden for service hereunder at the rates and upon the terms and conditions set forth in the applicable Electric Rate Schedule.
- B. The initial billing period shall start when Customer begins using electric power and energy, or 30 days after the town notifies the Customer in writing that permanent service is available hereunder, whichever shall occur first.
- C. Bills for service hereunder shall be paid at the office of the Town of Ayden, in Ayden, North Carolina. All bills not paid by the Due Date stated on the face of the bill will be charged a penalty as stated in the current year budget ordinance. All bills not paid by the Cutoff Date stated on the face of the bill will be charged a penalty as stated in the current year budget ordinance and will be scheduled for disconnection.
