“Counting our Blessings and Accomplishments”

For me, this is one of my favorite times of the year with the football season being at its peak with playoffs and bowl games, the beginning of the basketball season, the celebration of Christmas and the welcoming of a New Year. During this period of time we witnessed Christmas enthusiasm in our Town with the decoration of Christmas lights on our water tank, electrical poles, and the trees located downtown. The story of Christmas was told in our Churches with cantatas, plays, and sermons about the birth of Jesus. Christmas festivities were on display with an awesome parade that included the ECU Band Drum Line, Shriners, Santa Claus and all our community’s finest. Our joyous fellowship with each other at parties and family gatherings was enjoyed by everyone, and the magic of Christmas was experienced when Santa Claus visited our community on Christmas Eve. I hope you and your family have enjoyed the spirit of Christmas like my family has.

At Thanksgiving, I was reminded of how much the Lord has blessed the Town and my family. We have experienced a reduction in our electrical rates by 10%; approval for the construction of the Southwest Bypass; grants totaling \$11.5 million over 10 years; improved infrastructure (sewer and storm water); sidewalk expansion; development of Ayden District Park; renovated Ayden Community Center; and the list goes on. As a result, the Town of Ayden is moving in a progressive direction of transformation, growth, ownership, and hope.

As we enter into a new year, we have an opportunity to build on our blessings and accomplishments that will bring economic development and jobs. The Town of Ayden has a unique opportunity to create something special with the Food Processing and Manufacturing Initiative. 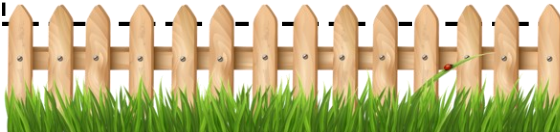

Medical Alert Program

If you or someone in your household are chronically or seriously ill or are on a life support system please notify our customer service department. A yearly certification from a doctor or hospital advising of the above condition is necessary to be placed on this program. A customer who complies with these notification procedures will have a special seal placed on his/her meter to designate his/her household as containing a chronically ill or life support customer. The Town will make every effort to keep the power flowing however, due to conditions beyond our control (storm damage, loss of generation, etc.) electric power can not be guaranteed 100% of the time. *Each customer must ensure a back-up plan for movement of a life-support patient if the Town is unable to restore power in a length of time that is acceptable.* Additionally, **each customer has the responsibility to handle his/her account so that service will not be interrupted for failure to pay.** For questions or concerns, please contact our customer service representatives at 252-481-5823.



Where can I put a fence?

Fences require zoning compliance. Fences and walls not over 5-feet high may project into or may enclose any front yard, except on corner lots where the max. height is 4-feet. Decorative or boundary fences or walls enclosing rear or side yards may be 6-feet high. A fence or wall may be erected in the side and rear yard to a maximum of 10-feet in nonresidential districts. All fences and walls must be constructed within the lot line. Fences shall be five (5) feet from all property lines which are adjacent to street right-of-ways.
