Description: The Commission shall consist of seven members appointed by the Franklin County Board of Commissioners. Terms are coterminous with the appointing Commissioner's term. There will be seventeen ex-officio voting members appointed by position. (These do not require official appointments by the FCBOCC). They are the Mayors, or their designees from their Boards, of Louisburg, Bunn, Franklinton, Youngsville and Centerville, two (2) County Commissioners, the Chairman of the Franklin County Chamber of Commerce, Franklin County Committee of 100 Chairman, Vance-Granville Community College Coordinator or designee for Franklin County Campus, Franklin County Planning Director, Director of Franklin County Public Utilities, County Manager, Airport Manager or designee for Triangle North Executive Airport, County Extension Director or designee for N.C. Cooperative Extension, N.C. House Representative and N.C. Senate Representative. Currently, Bobbi Jo May serves as a voting and ex-officio member as of September 25, 2009. The EDC promotes economic development and to establish a framework to be utilized in coordinating local, state and federal efforts toward this end. Major emphasis shall be placed on providing the basic facilities essential for attracting and encouraging sound economic growth in the county.
