(f) A named appointee from each franchise provider of ambulance service within Franklin County. (g) An Emergency Room Nurse nominated by the Administrator of Franklin Regional Medical Centers Administrator. (h) An Educator nominated by the Board of County Commissioners. (i) The Franklin County Director of Emergency Medical Services. (j) The seven public citizen members as appointed by the Board upon a recommendation of a member by each Commissioner with the terms of said appointees being coterminous with the recommending Commissioner.
