Franklin County Board of Elections

Board Meeting – March 2, 2020

The Franklin County Board of Elections met on this date at 5:00pm. The following were present at that time: Chairperson Sonravea Privette, Secretary Harry Barrick, M. Rose Gill, Barry Gupton, Angela Pearce, Director Michelle Chavis, and Deputy Director Colette S. Kneeland.

Chairperson Sonravea Privette called the meeting to order and turned the meeting over to Director Michelle Chavis. The Director requested that the Board Members allow her to step out of the meeting while she generated the lists of mail-in absentee ballots that were returned to the Board of Elections by 5:00 pm on March 2, 2020. Other Business items were discussed and the mail-in absentee ballots were reviewed.

Review Minutes from February 25, 2020 Board Meeting

The Board reviewed the minutes of the February 25, 2020 meeting. The motion was made by Board Member Barry Gupton, seconded by Board Member Angela Pearce to approve the minutes with corrections. The vote was unanimous.

New Business

Absentee Ballot Review

March 2, 2020

NCGS 163A-1308

Director Michelle Chavis gave the mail-in absentee ballot envelopes to the Board Members for review and explained the process of examining the envelopes for the mail-in absentee ballots. There were 2 military, 1 overseas and 81 civilian mail-in absentee ballots returned that were to be reviewed at this meeting. The Director explained that the military and overseas ballots that were returned by email will need to be duplicated and tabulated on Election Day by the Board. Chairperson Sonravea Privette inquired about the number of absentee ballots that have not been returned. The Director reported that 240 absentee ballots were mailed out and that 174 ballots had been returned.

After the review a motion was made by Board Member Barry Gupton, seconded by Secretary Harry Barrick to approve the 2 military, 1 overseas and 81 mail-in absentee ballots. The vote was unanimous.

Secretary Harry Barrick: 05-East Harris, 7-Pearces, 13-Pilot, 17-West Harris




Board Member Angela Pearce: 14-East Youngsville, 18-West Youngsville 1, 19-West Youngsville 2
