#### 7. Test Version of Demographics Question

(Stephanie Plancich, TPAC Administrator, 5 minutes) Attachment B

The test versions of the new demographics question are ready for beta testing as part of the joint Work Plan/Bus Plan engagement period launching on February 20<sup>th</sup>. The second beta test is planned during the SE Area Study engagement period expected to begin in March/April. The goal is to compile and analyze the test results and drafts path forward recommendations to finalize the demographics question and process by May/June to be reviewed in July as part of the annual Wake Transit engagement after-action and CE Policy review processes. CE members will receive the results and participate in those planning discussions. Full implementation in all Wake Transit efforts would begin in the new fiscal year.

The Wake Bus Plan Update and Draft FY2024 Wake Transit Work Plan combined engagement effort is scheduled to be presented to the public for review and comment from February 20 – March 22, 2023.
