As part of the last Wake Transit Work Plan Amendment Policy update, the TPAC created an option to hold a special Period of Performance (POP) extension request amendment cycle to provide project sponsors a method for requesting extension for agreements expiring in September since the regular amendment cycles did not align with those timing needs. It was the TPAC's goal to get all agreements onto a December expiration schedule and GoTriangle staff have confirmed that we have done it. Therefore, the special POP amendment cycle is no longer needed. POP Extension requests can now be submitted through the regular Q2 amendment process. The deadline to submit for FY26 2<sup>nd</sup> Quarter amendment will be in Mid-August with governing board approval scheduled in November.

  - a. Subcommittee Chair and Vice Chair Election
