Per the Wake Transit Work Plan Amendment Policy, the TPAC Program Development (PD) Subcommittee is tasked with reviewing amendment requests when quarterly amendment lists contain one (1) of more 'Major Amendment' requests. ## **Financial Policies Workgroup Meeting**

#### 1. Modifying the Operating Budget Carryover Policy Language

Members of the Financial Policies Workgroup will discuss a proposed modification to the 2021 adopted Wake Transit Financial Policies and Guidelines document. Questions arose about operating budget carryovers. CAMPO and GoTriangle staff met to discuss opportunities to clarify and streamline the process and are recommending the policy be updated to eliminate all operating carryover starting in FY26. Members will receive more details, including an example of policy language used by the Durham and Orange Transit Plans for discussion.

#### 2. Review of Financial Incentives Policy Statement Developed by Community Engagement Subcommittee

In May 2024, the Community Engagement (CE) Subcommittee approved new policy language that prohibits the use of Wake Transit revenue as an incentive for general public participation in outreach and engagement activities but allows funds to be used to purchase branded items and other specified uses. The action of the CE Subcommittee recommended that the language be included in both the CE Policy and Financial Policies and Guidelines. Subsequent conversations between lead agency staff have resulted in clarification that it only needs to be reflected in the CE Policy. Members will review the recommended policy statement and path forward.

#### 3. Quarterly Reimbursement, Progress Reporting, and Budget Transfer Tutorial
