The PD Subcommittee was tasked in May to review and comment on the draft of the Operations Security Funding Policy. At their June meeting, concerns were raised over significant details of the policy, and it was requested for input to be further sought in the development of the draft. A workshop was held in July consisting of members from both the Safety & Security Workgroup and PD Subcommittee to further develop details in the policy regarding eligibility, funding calculation and levels, the match requirement and mechanisms for the match, and others.

The subcommittee is now asked to review the policy to provide a recommendation to the TPAC for the adoption of the updated policy. The TPAC will be considering the release of the policy for public review at their August 28th, 2025 meeting to begin on September 5th.
