## Previous meeting date: 2/23/2021

**Highlights from previous meeting:** The subcommittee reviewed and discussed a draft scope to update the 10-year bus operations and capital plan. Jenny Green presented on behalf of the project sponsor GoTriangle. A short-range plan for all Wake County agencies will also be part of the scope with a planning horizon from FY24 through FY28. This project will not include any updates for the CRT, CFAP, BRT and Community Engagement Strategies. Project schedule would provide a NTP to consultant by May 2021, a draft plan ready to review by Spring 2022 and a final plan by summer 2022 with the associated public engagement throughout.

Bret Martin, presented on behalf of the project sponsor CAMPO, regarding a draft Policy Framework for use of Wake Transit Funds to Acquire and Dispose of Real Property. This will be a new Policy to be

adopted by the TPAC and appropriate executive boards. Items such as the following were discussed in detail. Thresholds were discussed for implementation of the policy based on property size and use. Would there be other viable uses for the property beyond the most immediate need. Would a purchase or long-term lease be more practical? Shared costs need to be disclosed as this will be important in the case of property disposal. Multiple options were presented for the subcommittee to review and there was good conversation with valuable input provided throughout the presentation. Final comments of the draft policy and presentation are due to Bret Martin no later than Friday March 12<sup>th</sup>.
