Highlights from previous meeting:

There was a brief conversation about all local fixed route agencies continuing the suspender fare through the end of FY22 (June 30, 2022).

David Walker, Chair with the City of Raleigh opened the floor to discussion for the Planning and Prioritization Committee. The only discussion was to the draft item 1 and 2 on the task list being duplicative. There was no other conversation. The committee took a vote and approved the work task list to be moved forward to the full TPAC for consideration.

Bret Martin with CAMPO reviewed the FY22 work plan amendment schedule.

Evan Koff, CAMPO provided an update on the FY21 Bus Service performance reports. Fare Box revenue recovery percentage is one of 4 performance measures (PM) and cannot be tracked due to the suspension of fares during the pandemic. There was active discussion on how this should impact tracking of the PM's. the pending Bus Plan update will be reviewing all of the PM's to determine if adjustments should be made adjusting for the pandemic.

There was also discussion on how to monitor services that are suspended during the pandemic. If a route is suspended for more than a year, then when it restarts, it could begin a new 18-month development period. For services suspended for less than a year brought further discussion. Ultimately it was decided that Bret/CAMPO staff would reach out to all agencies to review and consider a policy update to address these issues.
