#### V. <u>Election of TPAC Chair/Vice Chair</u>

Ben Howell, the elected TPAC Chair, announced that he had accepted a new position with a non-TPAC voting agency and would be stepping down after the August TPAC meeting. To fill the vacancy, CAMPO staff opened nominations for the Chair position. The TPAC was informed that the election would be added to the September 2021 agenda, and it was noted that the commitment would be for the remainder of the 2021 term.

Gaby Lawlor, the current TPAC Vice Chair, was nominated for the Chair position during that discussion and she confirmed her interest in being considered for the role but noted that she will be unavailable to Chair the TPAC meetings in November and December. Should she be elected to the Chair position, that leaves the Vice Chair role vacant. Voting members of the TPAC were encouraged to email nominations for themselves or others to stephanie.plancich@campo-nc.us, with the understanding that they could indicate whether their interest was for the Chair role, Vice Chair role, or both. Stephanie will close nominations at the start of this agenda item and will then conduct the election process.

#### VI. FY2023 Wake Transit Work Plan Kickoff

Additionally, CAMPO staff will explain the role of each staff person serving to those functions and will provide an update on CAMPO staff's assessment of the adequacy of the allocated resources.
