Highlights from previous meetings: It was not necessary to hold a meeting for two brief informational items, so the Chair cancelled the regular B&F meeting in lieu of providing a written update. The update included two attachments. First, was the FY23 Work Plan Development and Amendment Schedule. The second was the draft FY23 Work Plan Funding Request Form. Planning and Prioritization Subcommittee

Previous meeting date: 8/24/2021

Highlights from previous meeting:

Bret Martin representing CAMPO reviewed the FY23 work plan request form changes that have been made to reflect new requirements related to the real estate policy and other minor tweaks. He then also gave a brief recap on the bus service performance reports. CAMPO is now meeting with agencies individually to review projects and then reports out to the committee in an effort to keep committee meetings efficient.

The Committee then heard comments from individual agencies on upcoming projects or past projects that have seen delays or challenges. Raleigh discussed the challenge of purchasing real estate for projects such as the ADA operations and maintenance facility and east Raleigh transit center. Costs are escalating in Raleigh and land is getting purchased before we are able to act with regulations from the FTA on those projects that will also receive federal funding. Raleigh suggested that on future projects requiring land purchases that the funding be made available 2-3 years in advance of the construction to allow more time and flexibility. Raleigh also noted that they are seeing construction costs escalate on projects such as the Poole Road park and ride and projected costs for the ADA facility are near \$50 million. Raleigh's only operating project this year is the Hillsborough St high frequency network route. Construction on I-440/Blue Ridge road and Hillsborough St continue to see pandemic related delays. Raleigh will be monitoring those projects to determine the best implementation date for this service.

GoTriangle has no operating projects in FY23 and stated they had no major capital projects outside of CRT. GoCary continues their bus stops improvements. Their multi-modal bus center is currently in NEPA process and they will be coordinating with Raleigh on their route 9 service that would connect with the new high frequency network service along Hillsborough street.
