V. <u>FY21 and FY22 Baseline Funding Reprieve and Reimbursement Request Consideration</u> (Action Item: Steve Schlossberg, GoTriangle, 15 minutes) **Attachment B**

At the August TPAC meeting, a brief overview of this reimbursement item was introduced by Tax District Administration staff. In short, the Wake Transit program prohibits supplantation of pre-Wake Transit baseline levels with new Wake Transit revenues. Each provider is expected to meet the baseline each year and submit reimbursements for Wake Transit programmed services. It is possible over the past 2 fiscal years that some providers were unable to meet the baseline due to driver shortages and COVID-19 impacts to transit service and fare collections. Staff are requesting a reprieve of the baseline levels for FY21 and FY22 and ask the TPAC to recommend approval of reimbursement requests for funds expended to implement Wake Transit projects and services.

<u>Requested Action</u>: Consider a reprieve of baseline requirements and recommend approval of submitted FY2021 and FY2022 reimbursement requests for Wake Transit programmed investments.

VI. <u>Notice of Workgroup Development: FY24 Work Plan-GTCR Workgroup</u> (Information Item: Anna Stokes, CAMPO, 5 minutes) Attachment C

CAMPO and GoTriangle staff have developed a new workgroup, the FY24 Work Plan-GTCR Workgroup. The first meeting was on September 8th and the group will continue to meet as needed through the FY24 Work Plan development cycle. With the release of the initial draft results of the Greater Triangle Commuter Rail (GTCR) feasibility study, it became clear that the various recommendations and implementation options have the potential to impact the Work Plan in a variety of ways. This workgroup will meet to discuss project funding and implementation scenarios to develop a recommended strategy.



Recommendations from the workgroup will be presented to the joint B&F and P&P subcommittees for review and finalization prior to being incorporated into the draft FY24 Work Plan. Staff from CAMPO and GoTriangle, the lead agencies responsible for all components of annual Wake Transit Work Plans, will kick off the FY2024 Wake Transit Work Plan development process at the TPAC's September meeting. The kickoff presentation will include schedules and instructions for submitting project funding request forms, logistics for project funding reviews by TPAC subcommittees, and the preliminary revenue and expenditure assumptions that formulate the anticipated funding available for FY2024 operating and capital investments. X. <u>Wake Bus Plan Progress Update</u>

GoTriangle staff will provide the TPAC with a progress update of the Wake Bus Plan update and Short Range Transit Plan development for GoRaleigh, GoCary, GoTriangle, and GoWake ACCESS. Since the project began in July 2021, TPAC members participating on the project's core technical team, stakeholder team, and engagement team have worked with the consultant, Nelson\Nygaard, and GoTriangle, the lead agency in meetings held monthly and as-needed. Tasks completed to date include a regional service assessment, an access to transit gap analysis, and two public engagement efforts. In this update, GoTriangle staff will provide an overview of progress on tasks, an update on the project schedule, and next steps.

XI. Wake Bus Plan Project Prioritization Policy

(Information Item: Anna Stokes, CAMPO, 5 minutes)

The Wake Transit Project Prioritization Guidance was drafted in 2020 as part of the Wake Transit Plan Update process. It established a set of 8 funding tiers that are used to program projected Wake Transit revenues to specific future transit investments. Available funds are allocated to projects and services in Tier 1, then Tier 2 and so on. Tier 7 provides funds for bus stop improvements and Tier 8 provides funds for bus service investments and the capital projects needed to support them. Prioritizing individual Tier 7 and 8 projects requires an updated Bus Plan Project Prioritization Policy (BP-PPP). The updated policy has been in review and discussion for several months as part of the Wake Bus Plan update process. The BP-PPP is a critical tool needed by the Bus Plan Update team to establish each transit provider's short-range investment plan. CAMPO staff will provide a brief progress update and share the BP-PPP development schedule as information in September. Then the final draft will be presented in October.
