VI. COVID Relief Funding Update

Transit partners submitted templates that detail how pandemic related funds received based on the Raleigh Urbanized Area (UZA) have been spent. These funds were received through the Coronavirus Aid, Relief, and



Economic Security (CARES) Act; the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA); and the American Rescue Plan Act (ARP). Funds from these sources are available for all operating activities that occur on or after January 20, 2020. Information collected through the templates submitted by transit partners includes the specific program funding came from; the amount distributed; the amount expended to date; allocation of funds by category; and additional detail on how the funds were used. Transit partners who received funding will discuss with the TPAC the information included in the templates.

VII. FY24 Community Funding Area (CFA) Program Update

The FY 2024 Community Funding Area (CFA) Program call for projects opened October 31, 2022, and closed January 6, 2023. Four (4) applications were submitted for consideration. CAMPO staff will provide a status update on the selection of projects to receive CFA Program funding at the TPAC's March meeting. CAMPO staff will also discuss the program's fiscal health now that its projects have been incorporated into the Wake Transit Plan's extended FY2030 planning horizon.

VIII. GoRaleigh BRT Program Update

(Information Item: Het Patel, City of Raleigh)

Raleigh staff will provide a project update for the Wake Bus Rapid Transit Program with special emphasis on the New Bern Avenue Corridor as it is anticipated to move into construction in 2023 and begin service in 2025. A status report and next steps will also be discussed for the three other corridors (Southern, Western, and Northern) with a larger updated on the Southern and Western corridors expected to be presented to the TPAC in April.

IX. Rapid Bus Extension Major Investment Study Update

(Information Item: Jimi Mitchell, Project Consulting Team – Nelson\Nygaard) Attachment E & F

In April of 2021, CAMPO staff kicked off a major investment study (MIS) that will develop and evaluate alternatives and ultimately select preferred alternatives for rapid bus or bus rapid transit (BRT) extensions from Cary to Research Triangle Park and from Garner to Clayton. These extensions would build onto two of the core BRT corridors included in the original Wake County Transit Plan, and which are being implemented by the City of Raleigh. The extensions were included in the Wake County Transit Plan Update, and the capital improvements thereof were assumed to be funded with State revenue sources in the FYs 2020-2029 Transportation Improvement Program. The consultant has developed a technical recommendation for a locally preferred alternative in each corridor, which was presented to the Core Technical Teams and Stakeholder Oversight Teams in October for feedback. A final round of public engagement occurred during November and December 2022, with anticipated recommendation of a final Locally Preferred Alternative early in 2023. Information can be found online at https://wakebrtextensionsstudy.com. Although the Locally Preferred Alternative will be presented as information at this meeting, the



consultant has recommended additional study on operations and project delivery methods to be conducted before the project can be assigned to a project sponsor or move through the Wake Transit Concurrence Process.
