## V. Bus Stop Improvements Update from GoTriangle, GoRaleigh, and GoCary

(Information Item: Paul Black, GoTriangle; Sara Tromba/Melanie Rausch, GoRaleigh; and Kevin Wyrauch, GoCary)

Bus stop improvements are included in the Wake County Transit Plan adopted in April of 2021, notably in Chapter 4 in "Other Capital Expenditures." The plan says, "Significant resources are allocated for capital infrastructure to support a rapidly growing local bus network. Expenses for bus infrastructure, which includes transfer stations, park-and-ride lots, bus stop improvements, bus maintenance facilities, sidewalk access and streetside facilities, and other improvements, are assumed to total \$173.8 million through 2030."

An effort to improve stops began with the initial implementation of the plan, and while some of the easy-to-construct stops are complete, some proved difficult and are still in process. New stops are added to the pipeline every fiscal year. Over time the pipeline of difficult stops plus new, easier-to-build stops makes the flow in the pipeline steady every year from a modest start. The goal is to improve all the stops in Wake County



to meet baseline ridership warranted assets like shelters and benches and have all stops meet ADA baselines as called for in multiple ADA transition plans in the region.

Providers will give an update of progress over the last two years from the various agencies making stop improvements or adding new stops to the system, as well as an overview of future planned work.

#### VII. Recommended FY 2024 Wake Transit Work Plan

CAMPO and GoTriangle staff will provide an overview of the draft of the Recommended FY 2024 Wake Transit Work Plan (Attachment B), with special emphasis on any changes made between the Draft and Recommended Versions in response to public and agency comment (summarized in Attachment C), the submission of new or revised funding requests, and an update on discussions regarding the future of the Vehicle Rental Tax Allocation.

The Draft FY 2024 Wake Transit Work Plan was released by the TPAC on February 15th for a 30-day public comment period which ran from February 20th through March 22<sup>nd</sup>. In late March and early April public comments that were received during the comment period were reviewed and considered by project sponsors and CAMPO Wake Transit Program staff. On March 28<sup>th</sup>, the Program Development Subcommittee held a meeting to review revenue and expenditure assumptions, discuss any changes to project assumptions, and to recommend projects for inclusion in the Recommended FY 2024 Wake Transit Work Plan. The subcommittees agreed that the scope details and assumed expenditures associated with the projects included in the attached draft of the Recommended FY 2024 Wake Transit Work Plan were appropriate to move forward for investment.

<u>Requested Action</u>: Consider recommending approval of the Recommended FY 2024 Wake Transit Work Plan to the Wake Transit governing boards.

#### X. Other Business

- FY 2023 Wake Transit Amendments: No amendments were received during the FY23 Q4 amendment cycle. The deadline for the Special Period of Performance (POP) Cycle, the final amendment cycle for FY23, is May 26th 2023. This special amendment request cycle for POP extension requests was recommended by the TPAC as part of the Wake Transit Work Plan Amendment Policy update expected to be adopted by the Wake Transit governing boards in fall 2022. This 4th scheduled amendment cycle ONLY allows POP extension requests for projects with agreements set to expire in the upcoming fiscal year. These requests are not subject to the public or subcommittee review processes prior to TPAC consideration.
- GoTriangle Response to COVID Funding Questions: In response to the COVID funding agenda item and discussion at the March TPAC meeting, GoTriangle has provided a letter for TPAC review to clarify any outstanding issues. This letter was sent out to TPAC members by David Eatman (TPAC Chair) on Monday, April 3<sup>rd</sup> and has also been provided as an attachment to this agenda (Attachment F).
