
Phase 3 engagement, the draft review period, for the 2035

Howell provided an overview of the Phase 2 engagement summary report, outlined the engagement strategy being developed for Phase 3,
Attachment A, and then walked through the components of the draft 2035 Wake Transit Plan with focus on our updated financial assumptions and the draft investment strategy.

REVENUE ASSUMPTIONS

10-Year Revenue – Overview

- FY26–FY35 Revenue estimated at \$3.3b
- 90% of funds are from four sources:
 - 1. Sales Tax 50%
 - 2. Long Term Bond Proceeds 24%
 - 3. Baseline funding (multiple sources) 9%
 - 4. Federal funds (multiple sources) 7%
- Remaining 10% of funding equals \$330m (still a lot of funding)
- Potential challenges with funding assumptions ~ \$112m
 - Vehicle Rental Tax revenue = \$58m
 - Wake Transit Fare Box revenue = \$54m

6. Community Funding Area Program: FY 2026 Project Selection Results (Information item: Suvir Venkatesh, CAMPO, 15 minutes) Attachment C

There were four applications submitted for FY 2026 funding consideration: 2 from Apex, 1 from Holly Springs and 1 from Wake Forest. The Community Funding Area (CFA) Program Selection Committee met twice during the months of February and March to review and applications and has recommended that all four projects be included in the FY 2026 Wake Transit Work Plan.



CAMPO staff collaborated with consultants from Cambridge Systematics to begin the update of the Community Funding Area Program Management Plan (CFA PMP). Stakeholder feedback on the draft presented last Fall, Attachment C, and the fact that several key questions remained unanswered led CAMPO staff to delay adoption of the updated PMP until additional policy discussions related to the broader Wake Transit Plan update could be had. The original draft document produced by the consultant team is included as Attachment D. The updated adoption schedule and additional recommendations for incorporation into the draft plan were presented By Suvir Venkatesh.

8. Concurrence Plan for the Triangle Mobility Hub


