The recommended plan includes the projects selected to receive funding in the upcoming fiscal year (July 1-June 30) as well as an appendix that includes the Multiyear Operating Program and Capital Improvement Plan which identifies projects programmed to receive funding through FY2035.

Feedback received will be presented to the CAMPO and GoTriangle governing boards in June prior to their vote to adopt the Work Plan.
