
FY19 Work Plan Comments Summary

The FY19 Work Plan received 129 comments during the public comment period 1/23/18 – 3/12/18, including 9 letters from organizations giving formal comment. Outreach included pop-ups at transit centers, community


presentations, social media, a press release and online resources. A publicly available presentation detailed the FY19 Work Plan for online audiences and community, neighborhood and stakeholder groups. The majority of comments were submitted via email (65 percent) with the second largest source (29 percent) coming from offline events i.e. GoRaleigh pop-ups at Moore Square Station.



About a third of comments received (36 percent) centered on GoRaleigh services and a quarter (25 percent) related to the General Work Plan meaning they addressed projects and proposed changes in the plan other than those attributable to one agency. Comments on other service (i.e. to outer municipalities or referring to access vans, etc.) made up 11 percent of the comments and comments on

GoCary service made up 8 percent of comments. Other areas addressed included GoTriangle service, Other Activity (i.e. general practices or issues with transit) and Youth Fare Free. Please note, these categories address the overall message of the whole comment; youth fare free was mentioned in many other comments as well.
