VI. Release of Draft FY2022 Wake Transit Work Plan

(Action Item: Bret Martin, CAMPO and Steven Schlossberg, GoTriangle, 45 minutes) Attachment B

The TPAC and its assigned lead agencies are responsible for the development of all components of the annual Wake Transit Work Plan. This includes:

- Annual Operating Budget;
- Annual Capital Budget;
- Multi-Year Operating Program;
- Multi-Year Capital Improvement Plan (CIP);
- Update of the Wake Transit Financial Plan and financial model assumptions;
- Operating Funding Agreements; and
- Capital Funding Agreements

The TPAC is asked to review the work plan document in draft form and consider allowing staff to publish it for public review and comment. Several modifications to the original programming of FY2022 and subsequent year projects, as compared to the final reprogramming of investments through FY 2030 as part of the Wake Transit Plan Update, were requested through the FY 2022 Work Plan development process. These modifications include additional implementation elements, increases in assumed costs for a variety of projects, and updates to assumed project implementation schedules that combined result in notable impacts to the overall Wake Transit Plan implementation program. CAMPO staff will provide an overview of the FY 2022 Draft Wake Transit Work Plan to the TPAC at its February 17th meeting, with particular emphasis on these changes and their impacts. CAMPO staff will also provide an overview of some questions that remain for some projects proposed in the Draft Work Plan that were noted by the TPAC Planning & Prioritization and Budget and Finance Subcommittees in their review of project funding requests. GoTriangle staff will additionally provide an overview of the financials supporting the implementation elements requested for FY 2022 investment. The TPAC review draft of the FY 2022 Draft Wake Transit Work Plan is provided as Attachment B.

VII. Release of Draft Wake Transit Community Engagement Policy

Over the past few months, the GoTriangle engagement team has worked with other lead agency staff and the Public Engagement and Communications (PE&C) Subcommittee to finalize the draft Wake Transit Community Engagement Policy, which is an update to the Public Engagement Policy originally adopted in 2018. The TPAC received a presentation on the draft policy at its January 13th meeting. Comments received have been reviewed, and the draft has been updated appropriately. The updated Wake Transit Community Engagement Policy provides more specific guidance to Wake Transit partners executing engagement activities as part of their planning and project development efforts. The streamlined document is intended to be released for public review and comment with the Wake Transit Plan update and FY2022 Draft Wake Transit Work Plan on February 19th.

VIII. Wake Transit Plan (FY2021-2030) Update Progress Report

CAMPO staff will provide an overview of the document prepared for the Wake County Transit Plan Update to the TPAC at is February 17th meeting. Final investment program results for the plan update have been shared with the TPAC in prior meetings. The focus of the February 17th overview will be on the organization and content of the final plan update document and the next steps to support its ultimate adoption. Combined Wake Transit Engagement Strategy for Wake Transit Plan Update, Community Engagement IX. Policy and FY2022 Wake Transit Work Plan

(Information Item: Liz Raskopf, GoTriangle, 10 minutes) Attachments E-H

GoTriangle is the lead agency for Wake Transit program-level engagement and communications activities. In January, the TPAC supported a recommendation of the PE&C Subcommittee and Wake Transit Vision Plan Update Core Technical Team to merge the three upcoming public comment periods for the Wake Transit Plan Update, Community Engagement Policy and FY2022 Draft Wake Transit Work Plan into one coordinated campaign.

The combined engagement campaign will provide an opportunity for community members to comment on the three projects simultaneously. The campaign will be conducted in accordance with the currently adopted Public Engagement Policy, as detailed in the Spring 2021 Combined Wake Transit Engagement Strategy (Attachment E). The news release (Attachment F), presentation (Attachment G) and one-page flier (Attachment H) are provided for TPAC awareness and to use as they promote the county-wide engagement effort.

The combined campaign is anticipated to kick-off on February 19th. The following list shows the end date for each document's specific public comment period:

- FY2022 Wake Transit Work Plan 30-day comment period ends March 21st •
- Wake Transit Plan Update

40-day comment period ends March 31st

- Community Engagement Policy •
- 45-day comment period ends April 5th

Χ. Wake Bus Rapid Transit (BRT) Program Progress Update

(Information Item: Mila Vega & Het Patel, City of Raleigh, 15 minutes)

City of Raleigh staff will provide an update on the Wake Bus Rapid Transit program to the TPAC at its February 17th meeting. The New Bern Ave BRT project is currently working toward completion of 60% design plans and has recently received a \$35 million allocation in federal funds through the FTA's Capital Investment Grants (CIG) program. Next steps for the New Bern Ave BRT project include completing third-party agreements and the environmental review process (NEPA).

Staff will also provide a summary of program activities including branding, station design and public engagement. A second Virtual Open House is planned for late April, with both virtual and non-virtual components. Key upcoming milestones include:

- Review 60% design, branding, station design (Spring 2021)
- Southern Corridor Locally Preferred Alternative (LPA) TARGET (Spring-Summer 2021)
- Small Starts Ratings Application for Western Corridor - TARGET (Fall 2021)

XI. GoTriangle Regional Transit Center (RTC) Feasibility Study Progress Update

(Information Item: Jay Heikes, GoTriangle, 15 minutes)

The county transit plans for Wake, Durham, and Orange Counties identify the need for the relocation of the Regional Transit Center to improve route efficiency, connect to planned capital investments, and improve passenger amenities. Over the past year, GoTriangle in coordination with a variety of regional and municipal stakeholders, has completed an existing conditions assessment, identified site operational and location criteria, conducted public engagement, performed a site search, and identified and scored six candidate sites. The sites were scored based on improved access to the freeway network, proximity to planned bus rapid transit and commuter rail, access to employment, ease of site acquisition and construction, and access to future employment, retail, and services.

Following development of a conceptual program and evaluation of test fits on three final sites, GoTriangle staff and the GoTriangle Planning and Legislative Committee have identified and recommended a relocation strategy inclusive of a preferred location near the NCRR overpass of NC 54, a conceptual program, and an implementation approach. The GoTriangle board will consider endorsing this strategy at its March 24 meeting. Once the GoTriangle Board adopts the relocation strategy, staff would proceed with design and implementation efforts, including the following:

- Initiate site and facility design, including continued coordination with the commuter rail study as well as coordination with the bus rapid transit extension major investment study
- Develop a federal grant strategy and secure local funding
- Continued coordination with the property owner and evaluation of public-private partnership opportunities
- Completing environmental review, including adoption of a locally preferred alternative and obtaining concurrence consistent with the Wake Transit concurrence policy
- Continued stakeholder coordination and public engagement

GoTriangle has requested funds from the three county transit plans to complete design and land acquisition in FY22, with requests for construction funding following in FY23. GoTriangle staff believe this facility is a good candidate for multiple existing federal discretionary grant programs and will pursue any and all grant funding opportunities to help reduce the cost share borne by the county transit plans.
