**Previous meeting dates:** The most recent meeting of the Planning & Prioritization Subcommittee was held on July 28<sup>th</sup>.

**Highlights from previous meetings:** The subcommittee received a draft FY 22 Work Plan development calendar, a draft FY 21 and prior years Work Plan amendment calendar, and a draft project funding request form for the FY 22 Work Plan development cycle. The subcommittee discussed changes to the schedule for the FY 22 Work Plan development calendar that would delay the deadline for project funding requests until after the Vision Plan Update core design retreats in November so project sponsors would have clarity on which projects can be programmed for FY 22. The subcommittee also discussed delaying the release of the draft FY 22 Work Plan amendments. The subcommittee also agreed that making changes to future-year programming in the adopted FY 21 Work Plan that shake out from the core design retreats would best be addressed with the development of the FY 22 Work Plan rather than through an FY 21 Work Plan amendment. CAMPO staff agreed with these changes and incorporated them into the draft calendar.
