#### V. FY 21 Wake Transit Work Plan 1<sup>st</sup> Quarter Amendment Request

One (1) FY21 Wake Transit Work Plan amendment request was submitted by GoTriangle for the 1st quarter of the fiscal year. Documentation for the amendment request, including more information on the nature of the request, is provided in <u>Attachment B</u>. The amendment request falls into the Major Amendment category. Per the Wake Transit Work Plan Amendment Policy, the TPAC Budget & Finance and Planning & Prioritization Subcommittees are tasked with jointly reviewing Major Amendment requests. The subcommittees consider appropriateness of changes in scope or the scope of new projects and, if applicable, financial choices and trade-offs associated with proposed amendments. The subcommittees unanimously rendered a scope and financial disposition for the requested amendment at an August 25th joint meeting with a finding that the scope for the requested project is appropriate for the continued implementation of commuter rail as envisioned in the Wake County Transit Plan and that funding the request does not involve an unwarranted re-appropriation of funds. The amendment request was released for public comment between August 7, 2020, and September 6, 2020. No public comments have been received to date in response to the amendment request.

<u>Requested Action</u>: Consider recommending approval of the FY 21 Wake Transit Work Plan 1st quarter amendment request to the Wake Transit governing boards.

#### VII. <u>Community Funding Area Program Management Plan – Update to Appendix B: Program Funding</u> (Information Item: Evan Koff, CAMPO, 15 minutes) Attachment D

When the Community Funding Area Program Management Plan was originally developed and adopted in 2018, the program funding assumptions reflected in Appendix B, and upon which overall funding decisions for the program were made, did not account for the necessity of providing complementary Americans with Disabilities Act (ADA) paratransit service for fixed-route services. Through the development of the FY 21 Wake Transit Work Plan, the TPAC Planning & Prioritization and Budget & Finance Subcommittees made a recommendation to the TPAC to increase the amounts allocated to the Community Funding Area Program through FY 27 based on estimates of potential complementary paratransit costs that communities can reasonably be assumed to implement. The TPAC subsequently incorporated these funding changes into the program with its recommendation of the FY 21 Wake Transit Work Plan. To document this change to the program's funding assumptions, CAMPO staff has updated Appendix B: Program Funding to reflect the assumed additional costs tied to complementary ADA paratransit service. The update to Appendix B is provided as <u>Attachment D</u>.
