This phone-interview style survey captured overall community opinion and understanding of transit-related themes including: current travel behavior, awareness of transit services, awareness of planned improvements, attitudes toward public transportation as a community benefit and for personal usefulness and the nature of the current transit market. The results of this survey provide transit planners and other stakeholders with a county and regional benchmark from which to work.
