Jon Korin retired after a successful 36 year career in the IT industry ranging from startups to Fortune 100, products & solutions to services, and commercial and government. His last role was Vice President, Strategic Development for Northrop Grumman Information Systems, the \$8 billion information technology sector of Northrop Grumman Corporation, responsible for strategy development, mergers/acquisitions/divestitures, acquisition integration, new business assessment/launch and portfolio management. Previous roles at Northrop Grumman include Vice President, Strategic Alliances.



Previously, Mr. Korin was vice president of business development for PRC's Commercial Systems Group. Before joining PRC in 1990, Mr. Korin was with Oracle Complex Systems Corporation, where he was a founder and vice president of marketing and corporate development as well as senior management positions at Martin Marietta of Bethesda, Maryland, Lloyd Bush & Associates and The Service Bureau Company, both in New York City. He has started and grown IT businesses in decision support software, on-line financial services, document imaging systems and private network integration. He has extensive experience in structuring and managing acquisitions, divestitures and strategic alliances and has been a frequent speaker on these topics. He has chaired the annual Mid-Atlantic M&A Conference three times and has lectured at the Univ. of Pennsylvania, George Mason Univ., Hult International Business School and the Univ. of Virginia Darden School where he is a Visiting Executive Lecturer.

Mr. Korin attended the New York University Stern Graduate School of Business and holds a Bachelor of Science degree from the Wharton School of Finance and Commerce of the University of Pennsylvania. He is a past board member and president of the National Capital chapter of the Association for Corporate Growth; former Vice-chairman of the board of the IT Services Division and board and audit committee member of TechAmerica, the leading industry association for technology companies (formerly ITAA); and served on the board of directors of a startup software company through a successful IPO and subsequent go-private. Mr. Korin has also served as vice president of the board of the Olney Theatre Centre and on the board of the Carol Jean Cancer Foundation, a provider of summer camp and other services to children with cancer and their families.

He completed the [Leadership Anne Arundel](#) Flagship 2013 Program, is president of Severn Heights Improvement Association and is president and a founder of Bicycle Advocates for Annapolis & Anne Arundel County ([www.bikeaaa.org](http://www.bikeaaa.org)), an all-volunteer 501c3 with more than 700 members with a mission of promoting safe cycling for transportation and recreation. In 2015 County Executive Steve Schuh appointed him founding Chair of the Anne Arundel County Bicycle Advisory Commission. He was awarded the Maryland Recreation and Parks Association Community Volunteer Award for his leadership of the inaugural 2014 Lifeline100 bicycle event ([www.lifeline100.com](http://www.lifeline100.com)) and also recognized by the Anne Arundel County Public Schools Board for the Bike-minded Safety Program provided to over 5,000 school children.
