## ELECTION DAY BOARD MINUTES Tuesday, November 4, 2025 5:00PM

The Montgomery Board of Elections (BOE) met on November 4, 2025, at the Montgomery County Board of Elections office located at 327 N Main Street in Troy for the statutorily mandated Election Day Meeting. Members John Adams, Teddi Benson, Kelsey Brown, Debbie Burris, and Dree Wynkoop were present. BOE staff, Director Kimberly Walter and Deputy Director Donna Moore were present.

Chair John Adams called the meeting to order at 5:00PM.

The Board Meeting Agenda was presented. Member Wynkoop made a motion to approve the agenda. Member Benson seconded the motion. All were in favor. The agenda was approved.

November 3 2025 Absentee Board meeting minutes were presented. Member Burris made a motion to approve the minutes. Member Brown seconded the motion. All Members were in favor. The minutes were approved, signed and returned to BOE office staff to file and to post on the BOE website.

Board Review of Returned Absentee Ballots

Director Walter advised that no Absentee ballot packets have been returned since last board meeting and therefore, there were no Absentee ballots packets to review.

Chair Adams announced that after the meeting adjourned on November 3, 2025, the BOE staff obtained the correct Certificate requiring the Board Chair's signature. He stated that he came by the BOE office early this morning (11/4/2025) and signed the certificate to be submitted with the list of executed ballots. Director Walter announced that the Certified List of Executed Ballots and the Certificate signed by the Chair were submitted to the State before the established 10AM deadline.

Member Wynkoop made a motion to open the Absentee ballot box and to remove the Absentee ballots that have been run in the tabulator. Member Benson seconded the motion. All were in favor and the motion passed unanimously. Director Walter opened the tabulator, removed the box, and removed the ballots from the box, and announced that there were 7 ballots in the box. The Members reviewed and signed the result tape from the tabulator, completed/signed the required Abstract and Certification, and provided it to Director Walter to upload to the State.

Chair Adams announced that this meeting is to be suspended as the next item of business is to count the One-Stop (i.e., Early Voting) votes and the earliest that can be is at 7:30PM when the

polls close. Member Wynkoop made the motion to suspend the meeting until 7:30PM. Member Burris seconded, all Members were in favor, and the meeting was suspended at 5:13PM

Chair Adams returned the meeting from suspension at 7:31PM.

Director Walter announced the polls closed. The poll for Early Voting was closed with results tape printed and signed by all Members. The results tape and USB were provided to Director Walter to upload to the State. Director Walter advised there are no ballots to remove from the tabulator tub as the ballots are removed and sealed nightly. The Chair announced there was no Abstract needed for the Early Voting

With no further comments or business to discuss, Chair Adams called for a motion to adjourn. Member Brown made the motion to adjourn. Member Wynkoop seconded. All were in favor. The meeting was adjourned at 7:37PM.
