ABSENTEE BOARD MINUTES Tuesday, October 21, 2025 5:00PM

The Montgomery Board of Elections (BOE) met on October 21, 2025, at the Montgomery County Board of Elections office located at 327 N Main Street in Troy for the required weekly absentee meeting. Members John Adams, Teddi Benson, Kelsey Brown, Debbie Burris, and Dree Wynkoop were present. BOE staff, Director Kimberly Walter and Deputy Director Donna Moore were present.

Chair John Adams called the meeting to order at 5:00PM.

The Board Meeting Agenda was presented. Member Wynkoop made a motion to approve the agenda. Member Benson seconded the motion. All were in favor. The agenda was approved.

The minutes from the October 14, 2025 regular Board meeting, were presented. Member Brown made a motion to approve the minutes. Member Burris seconded the motion. All Members were in favor. The minutes were approved, signed and returned to BOE office staff to file and to post on-the-BOE website.

Board Review of Returned Absentee Ballots

Director Walter reported that the BOE received 12 Absentee Ballot Requests and mailed 12 Absentee Ballot packets to the requestors. She advised that 4 ballots had been returned and are ready for the Board to review. She noted that 4 ballots had been spoiled because some residents of the residential care facility in Mt. Gilead did not have them, and the facility could not find them during the MAT visit today although they had been delivered. The missing ballots were spoiled so they could not be returned as voted. She continued by stating that 2 of the 4 submitted a new Absentee Ballot requests today and those have been processed with packets mailed.

Director Walter presented the Board with the Absentee Voter Correspondence List and 4 sealed envelopes containing the returned Absentee ballots. Each Member carefully reviewed each return envelope and determined that 3 were to be accepted and 1 needed to be cured as it was submitted with an expired NCDL and did not comply with the Photo ID requirement. All Members signed the report verifying each Absentee packet received was reviewed and noting the decision to approve and/or cure specific packets.

Member Benson made a motion to open the accepted Absentee Ballot packets and run them in the tabulator. Member Wynkoop seconded the motion. All Members were in favor and the motion passed. Members confirmed the beginning count on the tabulator was zero and signed the

zero tape. Members Benson and Wynkoop ran each accepted ballot in the tabulator and announced the ending count on the tabulator was three.

With no further comments or business to discuss, Chair Adams called for a motion to adjourn. Member Wynkoop made the motion to adjourn. Member Burris seconded. All were in favor. The meeting adjourned at 5:18PM.
