ABSENTEE BOARD MINUTES Tuesday, October 28, 2025 5:00PM

The Montgomery Board of Elections (BOE) met on October 28, 2025, at the Montgomery County Board of Elections office located at 327 N Main Street in Troy for the required weekly Absentee Ballot review meeting. Members John Adams, Teddi Benson, Debbie Burris, and Dree Wynkoop were present. Member Kelsey Brown attended virtually. BOE staff, Director Kimberly Walter and Deputy Director Donna Moore were present.

Chair John Adams called the meeting to order at 5:00PM.

The Board Meeting Agenda was presented. Member Benson made a motion to approve the agenda. Member Wynkoop seconded the motion. All were in favor. The agenda was approved.

The minutes from the October 21, 2025 Absentee Board meeting were presented. Member Burris made a motion to approve the minutes. Member Wynkoop seconded the motion. All Members were in favor. The minutes were approved, signed and returned to BOE office staff to file and to post on the BOE website.

Old Business

Cured Absentee Ballot

Chair Adams announced that this ballot will be considered with the other returned Absentee Ballots to be presented for review in New Business.

New Business

Board Review of Returned Absentee Ballots

Director Walter advised that three ballots, including the cured ballot, had been returned and are available for the Board to review. She presented the Board with the Absentee Voter Correspondence List and three sealed envelopes containing the Absentee ballots returned since the last Absentee Board meeting. Each Member carefully reviewed each return envelope, determined that all those presented were to be accepted, and signed the report verifying each Absentee packet received was reviewed and accepted.

Chair Adams stated that motion to open the Absentee Ballot packets and to run the accepted ballots in the tabulator is not needed as the motion made and passed during the last meeting is a standing motion for the duration of the Absentee Ballot process. Member Wynkoop and Member Benson confirmed the beginning count on the tabulator was three, inserted the accepted ballots from this meeting into the tabulator and announced the ending count on the tabulator was six.

Chair Adams discussed the upcoming Board meeting dates/purposes as follows:

- Monday, November 3rd at 5PM for Absentee Ballot review (if there are no Absentee Ballots returned, there would be no meeting, but if there is at least one, the meeting will be held)

- Tuesday, November 4th (Election Day) at 5PM for Absentee Ballot review and Board will remain until after the election
- Tuesday, November 11th at 5:30PM regular monthly meeting is cancelled Thursday, November 6th at (time TBD) hand-eye count (proposed by Director Walter and approved by the Board)
- Thursday, November 13th at 9AM (tentatively) review provisional ballots
- Friday, November 14th at 11AM county canvass

With no further comments or business to discuss, Chair Adams called for a motion to adjourn. Member Wynkoop made the motion to adjourn. Member Burris seconded. All were in favor. The meeting adjourned at 5:20PM.
