MARRIAGE APPLICATION REQUIREMENTS

Marriage License are issued between the hours of 8:00am and 5:00pm Monday through Friday, excluding holidays.

Applicants are requested to arrive at our office prior to 4:30pm. Our office is in the Montgomery County Administration Building, second floor, at 102 East Spring Street, Troy, NC 27371- (910)-576-4271

The fee for the license is \$60.00 cash or card

To obtain a marriage license both applicants must present valid identification and Social Security cards.

Marriage license will be issued in the name as it appears on the identification.

Applicants must present a <u>valid</u> picture ID issued by the federal or state government. Example: current drivers license, <u>valid</u> passport, current DMV ID card (maybe verified)

Applicants who are 16-17 years old must have consent from a parent with full custody or both parents with joint custody or a person, agency, or institution having legal custody or serving as legal guardian of the applicant. Documentation of custody, if applicable, must be presented at the time of application.

Applicants who are 14-15 years old must present a certified copy of a Court Order issued by a District Court Judge authorizing the marriage along with identification requirements.

Identification Requirements:

- Over 21: All applicants must present a <u>valid</u> Driver's License or photo identification issued by a US Government Agency.
- Under 21: All applicants must present a <u>valid</u> Driver's License or photo identification issued by a US Government Agency plus a <u>certified copy or their birth certificate</u> OR alien registration issued by the US Immigration and Naturalization Service. <u>Foreign certificates must be accompanied by a notarized translation of the certificate in</u> English Language.

Foreign passports will be accepted if in English Language.

**A Marricular Consular or other similar document, other than a <u>valid</u> passport issued by a Consulate or Embassy or another country, is not acceptable for use in determining a person's actual identity or residency. N.C. Session Law 2015-294.

Applicants must provide a valid Social Security number. Presenting a Social Security card, W-2 form or income tax return with the SS number, will satisfy the verification requirement.

Applicants who are not eligible for a Social Security number may obtain a marriage license by presenting a <u>notarized affidavit</u> (affidavit form can be picked up in our office) that states "I have not been issued a Social Security number by the US Government, and I am not eligible to obtain one".

Date of divorce or date of death of previous spouse is required where applicable.

**You may be asked for other information as well as or different from the stated above.

The License is valid for 60 days from the date it was issued.
