QUESTIONS AND ANSWERS

1. Question: Regarding the fuel tank proposed on G-101 page 8, Drawing M-2, is the UL-142 acceptable to the local fire marshal? NC Fire code and NFPA 30, 30A, requires a UL 2085 fire rated tank for all types avgas and mogas gasoline application. Please advise if UL 142 is acceptable.

Answer: The UL 142 tank is acceptable per Chapter 11 AVIATION FACILITIES of the NC Fire code. NFPA 30A does require UL 2085 tanks, but that code is for "motor vehicle fueling facilities" and it does not apply to aviation fueling facilities.

This **ADDENDUM** <u>NO. 2</u> forms a part of the Contract Documents and modifies the original plan drawings and specifications dated June 2018 as noted and included herein. Acknowledge receipt of this ADDENDUM in the space provided on the Bid Form. Failure to do so may subject the Bidder to disqualification.
