BIOGRAPHY

Judge Ira Greenberg was born in the Bronx and grew up in Woodside Houses, Queens attending local public schools in Woodside and Stuyvesant High School.

He holds a bachelor's degree from the University of Chicago, a Master's degree in Public Administration from Baruch College, CUNY, a J.D. from Brooklyn Law School's evening program and was admitted to the bar in 1997. He practiced in in the areas of elderlaw, wills, trusts and estates and real estate and civil litigation from 1999 to 2018 in Woodside, Queens. He was co-counsel on a federal civil right trial resulting in a multimillion-dollar verdict and paved the way for improved polices in NYS prisons.

He worked for Member of Assembly Catherine Nolan in the NYS legislature on a variety of legislation including improving the public's input into MTA policies such as requiring a public speaking time at Board and Committee meetings and placing rider and labor non-voting representatives on the MTA Board and the MTA's contracting procedures.

After being appointed to the Permanent Citizens Advisory Committee to the MTA in 2006 and serving as its Chair he was appointed to the Metropolitan Transportation Authority Board from 2008 to 2018 chairing a working group on station disability access. He successfully advocated for the implementation of City Ticket on the Long Island Rail Road providing an affordable alternate for people commuting from areas not accessible to a subway. His other public service includes Community Board 2 where he served on the Land Use Committee; Sunnyside Chamber of Commerce Chair and pro-bono counsel to various community organizations.

Judge Greenberg was elected to the NYC Civil Court and began serving in Queens County in 2019. In 2023 he recommended legislation to expand Family Court's jurisdiction to include name changes for minors that was passed into law. He was appointed Supervising Judge of Queens Civil Court in January 2015. He served on the court system's Equal Justice in the Courts and Alternate Dispute Resolution committees and currently co-chairs that committee.
