After beta testing the platform for about a year with about 50 providers, including some in North Carolina, Lumata is ready to embark on a rapid expansion. To support these efforts, the virtual company of about 46 full-time employees plans to bring on a lot more employees over the next year. Grace said Lumata could end 2023 with a headcount near 200 employees. And as Lumata grows, the CEO anticipates the company will establish a physical footprint in the Raleigh area over the next two or three years.
