### Who is the Orange County Affordable Housing Coalition?

#### What is <u>Area Median Income</u> (AMI)?

AMI is the midpoint of a specific area's income distribution and is calculated on an annual basis by the Department of Housing and Urban Development (HUD). A family of four earning 30% AMI in Orange County makes just over \$30,000 per year.

# Your Vote Matters For Housing

This is a local election year. You can vote for who will represent you in town hall, on school boards, and more. It might not feel as a big as a presidential election year, but local elected officials have significant power to impact the issues you care about. This is especially true for affordable housing, where many important decisions are made at the local level by town councils and boards. Your vote is an opportunity to make a difference for affordable housing by electing local leaders who prioritize this issue.



One in three households in Orange County has trouble affording their home, including nearly half of all renters.



On Realtor.com, the median listing home price in Orange County, NC was \$539.9K in Sept 2023



Black homeownership rates in Chapel Hill have decreased by 32% since 2010.



Median homes sales prices in Chapel Hill have jumped 36% since 2020, making it nearly impossible for households earning less than \$150,000 to buy a home.

Housing bonds are a tool for local municipalities to raise money for affordable housing without drawing resources away from other services. Previous bonds were passed in Orange County (2016) and Chapel Hill (2018), generating funds that created hundreds of housing units. The candidates elected this fall will be part of the decision making process that could lead to a new bond on the fall 2024 ballot. Once a bond is on the ballot, voters hold the power to pass it.

### 2-Cents for Housing

Local governments fund affordable housing in different ways. Some methods dedicate a steady amount of funding every year and some are one-time opportunities like a bond. Dedicating two cents on the town's property tax rate in the annual budget is one tool to provide funds for affordable housing on an ongoing annual basis. This requires the Town Council to dedicate tax money towards an affordable housing fund.

Legion Road is a 36-acre town-owned property in Chapel Hill. The site will feature a new park, undeveloped green space, and 9 acres set aside for affordable housing. Households earning less than 30% AMI face extreme challenges securing housing. The high cost and scarcity of land is one reason that not enough housing is built at a low enough price point. Building affordable housing on land that the town already owns is one path to serve those with the lowest incomes.

Same Day Voter Registration is available during the Early Voting period at all Early Voting sites. If completing Same-Day Registration, one must provide proof of residency in Orange County, and must vote during Early Voting rather than on Election Day (which is November 7, 2023).

### What Photo ID can I use?

NC voters will be asked for a photo ID when they check in to vote. More info can be found at www.ncsbe.gov/voting/voter-id

#### Any of the following that is unexpired or expired for one year or less:

- North Carolina Driver's License
- U.S. Passport Book/U.S. Passport Card
- State ID from NCDMV ("non-operator ID")
- NC Voter Photo ID card, issued by a county board of elections
- College/university student ID approved by State Board of Elections
- · Charter school employee ID approved by State Board of Elections
- State/local government employee ID approved by State Board of Elections
- Driver's license/non-driver ID from another state, D.C. or U.S. territory (only if voter registered in NC within 90 days of election)

#### Any of the following, regardless of whether the ID contains an expiration or issuance date:

- · Military or veterans ID card (with photo) issued by the U.S. government
- Tribal enrollment card (with photo) issued by a tribe recognized by the state or federal government
- ID card (with photo) issued by an agency of the U.S. government or the State of North Carolina for a public assistance program

Note: A voter 65 or older may use an expired form of acceptable ID if the ID was unexpired on their 65th birthday.
