

Home Preservation Program

About the Program:

Habitat for Humanity of Orange County's Home Preservation serves low-income homeowners who struggle to maintain the interior and exterior of their homes. The program is designed to help preserve affordable homeownership and assist homeowners to live in healthy, safe and accessible homes.

Types of repairs include: Critical repairs (roof, HVAC, plumbing), accessibility modifications (wheelchair ramps, grab bars, and handrails), interior and exterior work (porch or deck, painting, patching, minor repairs).

Eligibility Criteria:

You must be a resident of Orange County, North Carolina.
You must own and occupy the home in need of repairs.
Your household income must fall below 80% of A.M.I. (Area Median Income).
Income guidelines are listed on the final page of this application.
You must be current on property taxes, mortgage payments (if applicable), and
homeowner's insurance premiums.

Costs:

If you qualify, you will be asked to pay a small portion of the repair costs using a sliding scale and payment plan.

How to Apply:

The Home Preservation application process is a multi-step process. Once, Habitat has received a complete application (with income documentation), we will schedule a home repair assessment to assist in determining your eligibility for program assistance. If approved for the program, the amount of time required to complete the home repair project depends upon the nature of the work, weather, the number of other families who have already been approved for the program, and other related factors

Income Guidelines: *

- **1 person:** Your family must earn less than \$47,500 in a year to qualify.
- **2 people:** Your family must earn less than \$54,300 in a year to qualify.
- **3 people:** Your family must earn less than \$61,100 in a year to qualify.
- 4 people: Your family must earn less than \$67,850 in a year to qualify.
- **5 people:** Your family must earn less than \$73,300 in a year to qualify.
- 6 people: Your family must earn less than \$78,750 in a year to qualify.
- 7 **people:** Your family must earn less than \$84,150 in a year to qualify.
