Love the Hill Days & Summer Project-Through blight & trash removal and beautification projects 2030 volunteers were mobilized to impact 8890 residents in 136 blocks of Allison Hill to create safer and more sanitary living conditions, reducing crime and giving hope. We hosted 187 volunteer events with 94 different organizations in 2024.

The Hill Farm-with over 41% of youth living in poverty and Allison Hill being a food dessert, 629 volunteers were mobilized to harvest 3578.98 lbs of produce that impacted 1177 families. There were 516 student visits through 27 educational events to teach about healthy living.
